We have reached a Tentative Agreement with the AGC of Washington for the Western and Central Washington Area Master Agreement. The agreement consists of quite a few language modifications and improvements along with a 12.49% total package Increase over the life of the three-year agreement. Your bargaining committee has chosen to utilize an electronic voting process. You will be contacted within the next week to attend a tele-town-hall meeting where the chairpersons of the bargaining team will go over the Tentative Agreement in detail with all members of the bargaining unit in attendance.
