Foreman - working member that supervises 5 or more members. General Foreman - OSHA 30 cert; supervises more than one foreman led crew.

*AGC Welder Premium is \$1.75 per hour over their group's journeyman wage rate. Minimum of 8 hours per day.

*GCCA Welder Premium is 5% per hour over their group's journeyman wage rate. Minimum of 8 hours per day.

Note:

- 1) Overtime is paid using the Taxable Wage (Taxable Wage X Overtime Rate) then the taxable deductions (Dues and vacations) are deducted.
 - 2) Training Contributions are based on 1.7% of the Group 1 Journeyman Carpenter gross wage (Taxable + Fringe).
 - 3) Fringe Benefits are to be paid on all hours worked (with the exception of Pension for 1st and 2nd term apprentices - Article 27) in addition to the taxable wage rate.
 - 4) Apprentices in the 1st and 2nd terms, when working on any State or Federal Prevailing Wage Projects shall have their Pension Fund contribution paid in full at the managing trust.
- Contractors signatory to AGC Agreements must pay UCG @ \$0.05
- Contractors signatory to GCCA Agreements must pay \$0.02 to CMF
- Drug Free Workplace @ \$0.13 per hour as per Article 7.5**
